RYE SOCIETY OF ARTISTS EXHIBITORS REGULATIONS 2018



ADMISSABLE WORKS: Works in painting, sculpture, graphic arts, mixed media, photography and ceramics are admissible. All original prints, including those digitally produced, must be numbered in editions.

Work should be handed in to the Dance Hall, Conduit Hill, Rye TN3 I 7LE from 7 - 8.30 p.m. on Thursday 26th JULY 2018 ALL WORKS MUST BE FOR SALE.

Non-members' works will only be received at the time stated.

INADMISSABLE WORKS: Printed reproductions of original artworks. We do not accept giclee copies. We do not accept copies or reproduced editions of original drawings or paintings.

All original prints, including those digitally produced, must be numbered in editions. (a digital print is only considered an 'original print' if it was created by the artist to be realised specifically as a print in this specific format). Works in excess of 12 sq.ft. or 1.5 sq.mtrs, including frame, will be hung only at the discretion of the Hanging Committee.

LABELLING: All works are to be labelled with title, price, medium, name and address of artist.

Pictures should be framed, labelled on the back, and fitted with a second label, with all the information, on a string long enough to hang over the front of the picture for cataloguing the works after they are hung.

Printmakers and photographers should also include details of the availability and price of any unframed prints on the hanging label.

Pottery and 3-D work must be free-standing and clearly labelled with the artist's name, the title, description, medium and price on each item.

The artist's name should be written on the form as it will appear on the exhibition label.

D-RINGS ONLY are to be fixed to the back of frames to avoid damage when stored. The Hanging Committee hope to be able to hang all of the works selected, but only within the constraints of the space available and the compatibility of the works.

Number of non-members works acceptable:- Up to 2. Submission fee: £5.00 per work.

3D artists may submit up to 4 pieces for a maximum fee of £10 There is no additional hanging fee.

Non-members must be living within a 15 mile radius of Rye

COMMISSION FEES on sales:

Non-Members 35%, whether the sale be effected by the Exhibition Authorities or the Exhibitor.

ACCEPTED WORKS MAY NOT BE COLLECTED OR REMOVED DURING THE EXHIBITION. WORKS NOT ACCEPTED MUST BE COLLECTED ON WEDNESDAY 1ST AUGUST 6 - 7.30 PM.

ARTISTS WILL BE RESPONSIBLE FOR INSURING THEIR OWN WORKS AGAINST LOSS OR DAMAGE. The Society, whilst taking great care of work submitted, will not be held responsible for any loss or damage incurred during the Exhibition or in transit.

BOTH THE ATTACHED FORMS ARE TO BE SUBMITTED WITH THE WORKS, NON-MEMBERS MUST ENCLOSE THEIR FEE AND S.A.E. SIZE C5 FOR NOTIFICATION. THE SELECTION COMMITTEE'S DECISION SHALL BE FINAL ND EACH ARTIST WILL BE NOTIFIED. NO CORRESPONDENCE WILL BE ENTERED INTO REGARDING THE SELECTION.

Works must be removed on TUES 28th AUGUST from 2 - 4.pm. For security reasons work will only be returned on production of the receipted collection form. EXHIBITORS ARE RESPONSIBLE FOR THE REMOVAL OF ALL THEIR WORKS, BOTH SOLD AND UNSOLD, ON COLLECTION DAY *TUES 28TH AUGUST*. IN THE EVENT OF A WORK BEING SOLD BUT NOT PAID FOR IN FULL BY COLLECTION DAY, THE WORK WILL BE RETURNED TO THE ARTIST ONLY, WITH FULL DETAILS OF THE OUTSTANDING TRANSACTION.
