General working practices & guidelines for models:

The following information relating to the working practices of Peter Liggins Photography is set out below for the protection of models engaging in photographic work and is strictly non negotiable.

Health & Safety

The health and safety of all models engaging in photographic work is of paramount importance to me. With regards to location, Peter Liggins Photography will never place a model in any situation where his/her/their/its safety is compromised. I am committed to safe working practices at all times and any location, theme or activity at the request of the model(s) is subject to the discretion of Peter Liggins Photography prior to engagement.

Legal & Moral Practices

1. Peter Liggins Photography will not engage in any photographic work that promotes, displays, glamorizes or glorifies any of the following: homophobia; islamophobia; far right extremism; violence; cruelty; sex trafficking; drug trafficking; pornography; illegal trading of animals; crime etc. This list is subject to addition and change at any time and is strictly at the discretion of Peter Liggins Photography

2. Peter Liggins Photography will not engage in any photographic work that discriminates or prejudices against any of the following: LGBT Community; Ethnicity; Gender; Race etc. This list is subject to addition and change at any time and is strictly at the discretion of Peter Liggins Photography.

Genre & Theme

Peter Liggins Photography does not engage in photographic work in any of the following genre & themes: Fashion; Glamour; Boudoir; Burlesque; Topless; Naked; Sexual Activity etc. There are many photographers at hand who specialize in this type of work and can be contacted accordingly via various channels and networks.

Children & Minors - (Child) or (Minor) as defined by law: Any person under 18 years of age.

1. All children/minors engaging in photographic work with Peter Liggins Photography must be accompanied by a custodial parent or legal guardian (any other adult is unacceptable).
2. All parents/legal guardians must sign a MRF (Model Release Form) prior to any photographic work taking place.
3. No child/minor will be photographed (as deemed by Peter Liggins Photography) in clothing that could be viewed, interpreted or portrayed as inappropriate.
4. The child/minor has the right to refuse to be photographed once on location. Should this situation arise, Peter Liggins Photography will respect this decision regardless of parental choice.

Dogs (Pets Or Other)

Peter Liggins Photography understands that pets can be unpredictable and at times unresponsive in front of the camera, often resulting in unnatural looking portraits. My experience shows that pets are best photographed in an environment which they are familiar with and relaxed around strangers (photographer). I will spend a little time getting to know your pet prior to any shoot. It is surprising how many pets are alerted to the click of the shutter! I work mostly in natural light as artificial lighting (strobes/ flashguns/studio lighting etc) have proven to be too sensitive on an animals eye.

*** A note to dog owners***

Photographing dogs is hit & miss! The photographer can shoot up to 300 frames in a single shoot with sometimes only one acceptable image. This is a common occurrence due to many factors, and is completely unavoidable. In such a scenario, Peter Liggins Photography will reschedule at no further cost to you.

All dogs must remain under the complete control of their owner(s) at all times during any shoot.

Copyright shall remain the property of the photographer at all times. The use of images from any shoot will remain in strict accordance with the terms & conditions set out in the MRF (Model Release Form)
